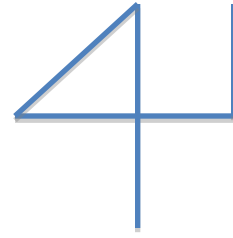

THIS SERVICE IS SUBJECT TO THE FOLLOWING:

1. Mare must be halter broke. Mare shall be checked to be in healthy and sound breeding condition by a veterinarian. Any previous breeding problems shall be disclosed to the Breeder.
2. Breeder agrees to diligently try to settle mare. Mare Owner agrees to give the Breeder ample time to settle mare. If the mare does not settle rebreed privileges will be available.
3. **Live Foal Guarantee:** Shall pertain only to mares that have been pronounced **Safe in Foal by a Veterinarian within 30 days** after the last breeding date. Said results must be sent/phoned to Breeder. A Live Foal is described as a newborn foal which stands and nurses without assistance. If foal is born dead, or the mare aborts the Mare Owner has Rebreed privileges the following breeding season only if Breeder is notified within 7 days by a veterinarian.
4. **Rebreed Privileges** are for the following season only. The breeding fee will not be refunded. If the Mare Owner fails to return the following year, then any and all fees paid shall be forfeited, the right to rebreed is canceled and breeder is released from all obligation of this contract.
5. If the stallion dies, or becomes unfit for breeding prior to settling mare, the breeding fee (less booking fee) will be refunded.
6. Mare Owner is responsible for all veterinarian fees. Before the mare leaves Four Lazy F Ranch all unpaid board, expenses and fees become due and payable.
7. A Breeder's Certificate will be issued for the foal when the mare has produced a live foal from this breeding and all expenses have been paid in full.
8. It is further agreed that Breeder shall not be held responsible for disease, accident, or death of the mare and/or foal while under their care.
9. Breeder will not hold Mare Owner responsible for any disease, accident, or injury to their stallions, mares or foals.
